The runs will be coded as follows for easier identification by Life Force Management and credit to each entity to receive funds: N = non-resident of Village or Township, V = Westfield Village, R = non incorporated Township and G = Gloria Glens. Mark was pleased at the good response to calls recently and also to the association meeting.
