Comments from the Floor: None

### **Chief's Report:**

35 total calls- 27 squad and 8 fire; 20 township, 5 Village, 9 Lodi and 1 Seville

- Elementary Summer School Safety City Days went very well. Five area fire departments and law enforcement agencies talked with preschoolers and showed them the emergency vehicles.
- The department received notification of EMS Grant awarded in the amount of \$3,250.00. This is offered each year by the State Fire Marshal's Office. This is our fourth year to receive this money. This grant covers training for EMS responders.
- The department will participate in the Chippewa Sweet Corn Festival Parade on July 17<sup>th</sup> and will sell root beer floats for our annual fund raiser.
- The front bay drain grids are uneven and eroding so a solution needs to be made. Estimated
  cost of \$900.00 will not suffice, so an upgraded solution would be a more viable but also cost
  more. The current quote will not exceed \$3000.00. Likley would like to look at alternative
  options to this costly upgrade.

## **Old Business:**

- ➤ 2010 Pumper truck has had some maintenance: problems with lights, corroded battery and vacuum fixed by Carnegie Federal Body, LLC for the cost of \$3791.50. Squad will cost \$854.00 for back up alarm system. Total cost to Carnegie was \$4645.00.
- County completed hydrant flow test (ISO Inspection) and the chief will be reviewing results and communicate with the trustees the results of these tests.
- > Dry Hydrants- 6 in the area and 5 out of 6 have been flushed out and tested.
- Fire Contract to be signed.

Likley makes a motion to have the WFRD enter into a contract to provide services for the Village of Westfield Center, and Westfield Township; seconded by Thombs.

Discussion: Village will sign at their next meeting.

#### **New Business:**

- Records Retention Schedule- reports will be provided to the Ohio Historical Society and then to the Attorney General's Office.
- Likley stated that the state audits (financial audit) about every 2 years and that all township bids and operations need to be maintained for 3 years. Present Retention Schedule has been reviewed but can be amended and it is then sent through the same process.
- > The Chief mentioned that in 2012 the WFRD was part of the Village's audit.

Bills and warrants in the total amount of \$18,729.67 and the fund status in the amount of \$119,884.10.
