Fiscal Officer's Report

Kathy Zweifel was not at the meeting so Cheryl Porter gave the Fiscal Officer's Report.

- Bills and Warrants in the amount of \$15,479.63
- Fund Status is in the amount of \$139,324.66

Schmidt questioned the purchase by the department for their dress blues. Likley said the first set of dress blues are provided by the WFRD.

\$4,725.00- was to purchase turn-out gear (2 sets of jackets and pants).

\$1,760.00- was to purchase foam to replace from previous fire.

Thombs asked about the \$900.00 that is left in the township account for WFRD expenses and can this be used for anything.

Likley said it can't be transferred but it can pay a bill and the township money should be spent in its entirety. We will recommend to the fiscal officer to expend the \$900.00 for fire money.

Thombs asked for the record to reflect that the purchase of the emergency sirens were paid from the Township accounts.
