### Regular Meeting

May 4, 2015

Likley calls the WFRD meeting to order at 6:00 PM. Roll call: Schmidt- aye, Likley- aye, Thombs- aye. No comments from the floor

#### <u>Chief's Report</u>

- > Total runs were 39. EMS- 27, Fire and Rescue- 11, Motor vehicle- 1
- > 26- Township, 8- Village, 2- Lodi, 1- Lafayette, 2- Seville.
- Medicount Management Safety Pad- This is a program that will upgrade the WFRD ePCR. This system will save approximately \$200.00 per month. This program will be cheaper, faster and easier. The cost will be \$1.45 per run and data will cost \$6-7.00. There is a onetime start-up cost of \$1200.00 that will be recovered quickly. Contract will be coming.
- The department underwent a review by the Insurance Service Office (ISO) on April 22<sup>nd</sup>. The last rating was 18 years ago. They check on equipment, employee training and pump testing. WFRD will hear about the results in about 4-6 months.
- CPR classes will be held at the high school in the next coming weeks. This is their third and final session.
- Memorial Day Parade will be at 11:00 AM.
- > Open House/ Safety Days will be on June 6<sup>th</sup> from 10:30 AM- 1:00 PM.
- National EMS Week is May 17<sup>th</sup>-23<sup>rd</sup>. Lodi Hospital is organizing a Rubber Ducks' Game on May 20<sup>th</sup>.
- Chief Fletcher will be off May 20<sup>th</sup>-30<sup>th</sup>. The officers will handle business at the fire house during this time.
- > The Chief would like to purchase the Safety Pad at a cost of \$1200.00.

# Likley makes a motion to proceed with the purchase of the Safety Pad with Medicount Management at a cost of \$1200.00; seconded by Schmidt. Roll call: Schmidt- aye, Likley- aye, Thombs- aye. The motion passes.

Total truck replacement cost is \$475,692.00 paid by insurance. Price may vary due to some electric cords. There may be some cost to the WFRD for the additions (electric battery unit for the jaws-of-life and chains) and Chief will have exact price at next meeting.

#### Fiscal Officer's Report

• Bills in the amount of \$16,119.70. Likley would like to not pay the bill to the Technical Rescue Team payment in the amount of \$1,421.53 at this time.
