- Chief provided the Trustees with his 2015 Yearly Report
- Run Report- 21 total runs; 11 EMS, 4 fire, 4 MVA including 17 in township, 2 in Village, 1 in Seville and 1 in Wadsworth.

- Toy and food Drive with Seville-Guilford was a great success. Area families in need were helped throughout the holidays with remaining gifts donated to Akron Children's Hospital
- State Fire Marshal Fire Safety Poster Contest has two state winners from the Cloverleaf Elementary Schools. The posters will be placed on the State Fire Marshal's website and will be used to create a 2017 calendar. The names are withheld until the winners are notified by a State Representative and will be officially presented with an award. Thombs would like to invite the winners to a Board Meeting and also present them with an award from the Chief and Trustees. The tentative date will be 2-1-16 at 6:00 PM.;
- There are three members attending EMT- Basic class this month and one member (she is presently a nurse) is attending Paramedic Classes beginning this month.
- New EMS Coordinator at Lodi Community Hospital. Hugh Dodd will also be the guest speaker at our EMS continuing education class at the station on Monday.
- The Chief has checked into another company for accident and health insurance for WFRD
 members. Volunteer Firefighter Insurance Service (VFIS) is a division of Glatfelter Insurance
 Group. A comparable quote will be available later this week.
- Truck update: Pre-paint inspection will be around the 15th of January. Truck should be done the end of March. The company would like to take the truck to Indianapolis the third week of April to a conference. The company will compensate the township for the use of this truck and the rental. The Chief feels this builds a nice relationship with the dealership and the township will gain recognition. Likley would like Guilford to be made aware of any extended time needed for the rental.
