Chief's Report

- Total number of calls was 33; squad included 26; fire 5; motor vehicle accidents were 2. This included 18 in the township; 11 in the Village; 1 in Lodi; 2 in Seville and 1 in Lafayette.
- WFRD will participate in the Cloverleaf Elementary Safety City Day on Wednesday, June 14th between 9 11:30 AM. Lodi, Seville, Chatham & Lafayette have also been asked to display equipment & do demonstration for the pre-school children.
- Chief Fletcher arranged a preventative maintenance program with Fallsway Equipment for the fleet. He toured the facility and was impressed by their operations. This program will allow us to use 1 facility for maintenance & repairs. The first truck scheduled is the 1999 Pumper/Tender on Thursday, June 13th including maintenance to the air connection lines.
- The new fire station committee met to discuss future plans. The architect has been instructed to maximize costs of \$2.6M. This meets the value amount in the Fire District and will be designated as a Fire Station only.
- Chief Fletcher and other members of the WFRD will be touring the NE Ohio Railway Museum to become familiar with the layout. Suggestions were made to enhance fire safety and Railway staff were trained on proper use of fire extinguishers. Water will be accessible from a buried tanker on the property with 30,000 gallons and a hydrant at the top.
