Fiscal Officer

- A discussion was had regarding the Temporary Appropriations as presented. These appropriations will allow the payment of bill between January March 2018. A resolution will be presented at the December 18, 2017 meeting for Trustee approval. Permanent Appropriations will be presented and approved after Trustee-Elect Horner takes his post.
- Temporary Appropriations include Audit Fees for the 1st Quarter in case they cross in the next year.

Chief's Report

- Trustee Likley discussed Supplemental Insurance. There was a meeting with Aflac. An e-mail was sent to Township staff regarding what the current coverage is and what the cost of additional coverage would cost. WFRD does not want the Department Members to be financially at risk if there were an injury however coverage cost is also a concern.
 - o AD&D is currently in place with VFIS
- Chief Fletcher discussed the VFIS AD & D (Accident Death & Disability) insurance and
 additional coverage for critical illness for active members. He had provided this information in an
 e-mail to the Trustees. The discussion is basing the Worker Compensation scenario on the
 member getting hurt on WFRD time. AD & D does not matter where the injury occurred.
 - O The current supplemental coverage is \$1,299.00 annually to supplement Workers Compensation. Workers Comp does not pay until day 29, the supplemental will pay the first 28 days plus the difference starting day 29. The payments will be paid based on the member taxable income. WC pays 2/3 of the payment and VFIS will pay the 1/3.
 - O Active members are measured by having an average of 4 runs per month, currently 16 members. An agreement of payback will be in place for those members who fall short of that average. Critical Coverage is a one-time payout of \$10,000.00 and other employment is irrelevant.

Likley makes a motion to accept the additional VFIS Critical Illness insurance coverage for active members at approximately \$96.00 per person; seconded by Thombs. Roll call: Schmidt – aye, Likley – aye, Thombs – aye.
