# Westfield Fire and Rescue District

## Regular Meeting May 7, 2018

Trustee Likley called the meeting to order at 6:30 PM. Roll call: Horner – aye, Schmidt – aye, Likley - aye.

#### Chief's Report

- Total number of calls was 33; squad included 17; fire 8; and motor vehicle accidents were 8. This included 26 in the township; 4 in the Village; 2 in Lodi and 1 in Lafayette. 20 residents & 13 non-residents were involved.
- The bi-annual Prom Promise/Mock Crash Drill was held last Monday morning at Cloverleaf High School. Many agencies participated in the event including Local and State Law Enforcement, Lodi, Seville-Guilford, Lafayette, Chatham as well as WFRD, Metro Life Flight, a Funeral Director and the County Coroner. Channel 3 WKYC was on hand for new coverage. The hope is to send a message to the teens for a safe Prom & Graduation season.
- The Annual Open House was on Saturday, May 5<sup>th</sup> at 12 3 PM. Refreshments, Fire Safety Magician @ 1 PM and Fire Safety Tips were a part of the program. About 25 children were entertained by the magician. A toy Pedal Fire Truck will be raffled this evening, May 7<sup>th</sup>. Overall the event was well attended.
- The Levy Committee worked hard towards getting the word out to the community. Every resident in the township has been covered by the door-to-door campaign. We hope for a good and positive turn out for elections day tomorrow, May 8<sup>th</sup>.
- WFRD received a BWC Grant in the amount of \$8,200 for the purchase of new Firefighter Hoods and Gloves worn during fire operations. These are state of the art items with added protection against exposure to cancer causing contaminants. This amount covers 2 sets of gloves and 1 hood for each member.
- Chief Fletcher met with the County Health Department and received special Naloxone (Narcan) kits specifically for first responders. Often when responding to overdose calls, the first responder becomes a victim. These special kits are reserved for responders only. Narcan kits are at no cost to WFRD. WFRD monitors the expiration dates on the kits and replaces them when necessary.
- Squad 167-2 has a few more weeks before repairs are completed.
  - Any additional insurance funds will be directed to Fallsway Equipment who is doing the repair work.
  - o Trustee Schmidt inquired if there were any potential defects in the squad that resulted in the incident. Chief Fletcher stated it is being researched but appears to be operator error.
- Due to the FDIC conference there are no updates regarding the new squad. Since not all of current trucks/squads have hour meters, meters will be installed on all new equipment.
