Comments from the floor

Chief's Report

- Total number of calls was 31; squad included 18; fire 12; and motor vehicle accidents 2. This included 23 in the township; 7 in the Village; and 2 in Seville. 27 residents & 5 non-residents were involved.
- The 1999 Pumper/Tender is still out for repairs. There was significant work needed for the rear breaking system. There are 4 separate brake pads and drums included in the system. Apparently only 40% of the brake pads were in contact with the drums causing the front brakes to do most of the work. Along with the brake repairs the rear air ride system needed to be repaired due to corrosion to the body support plates. The total repairs are estimated to be \$8,000. F.O. Haendiges reported that there is currently \$4,250 currently in the budgeted line item for repairs. She will need to reallocate funds to cover the difference. This is the largest Pumper/Tender in the county and it carries 2,300 gallons of water.
- A portable generator will also be installed in the Pumper/Tender that will operate with a turn key inside the cab. This installation will cost approximately \$3,500. The custom installed generator has not been working for the past 6 years so this truck had no electrical support for scene lighting and tool operation. A replacement cost would be over \$30,000 so this option was a huge cost savings.
