Trustee Likley called the meeting to order at 6:30 PM. Roll call: Horner – aye, Schmidt – aye, Likley – aye.

Chief's Report

- Total number of calls was 26; squad included 20, fire 4; motor vehicle accidents were 2. This
 included 20 in the township and 6 in the Village. 20 residents & 6 non-residents were involved.
- Last weekend we changed clocks back 1 hour to return to local standard time. This has always been a reminder to also change the batteries in your smoke detector: "Change your clocks, Change your batteries". For the past 2 years we have partnered with Lodi Fire Department and provided smoke and carbon monoxide detectors to residents in need. To date over 400 have been installed in WFRD area residents' homes. Chief Fletcher stated in his 38 years of service he has never had a fatality when there were working smoke detectors.
- Last week the department underwent the Insurance Service Office (ISO) evaluation. This is a rating given to determine most insurance premiums. This rating takes into consideration the Dispatch Center, water availability for fire protection and the Fire Department. We will not receive the formal rating until January, however, the evaluator stated we should improve since staffing was added since the last rating. We are currently are at a Class 05/5X on a 1-10 scale. 1 being the best rating.
- WFRD will be conducting CPR classes at Cloverleaf HS on Wednesday. There will also be tours
 of the station for the Leroy UMC Pre-school on Thursday and Friday. Saturday there will be an
 Active Shooter Drill at Westfield Insurance.
- The Association will be hosting Breakfast with Santa on Saturday, December 7th at the Township Hall. Breakfast will be served from 9:00 11:30 with Santa arriving at 9:30 AM. The cost is \$5.00 for ages 13 and over, \$2.00 for ages 4 12 and kids under 3 are free. Pictures with Santa and Mrs. Claus will be available online through WFRD's website.
- Pumper/Tender 162 out of service for engine repairs until mid-week.
- Auto-mutual status –Presently at 31 call requiring auto mutual aid. 6 members are below the minimum(s) for runs. Will explore campaign ideas to recruit new members. There are several new residents so reaching out to the community may help.
- May need a work session during budget season to address pay and recruiting.
