#### Chief's Report

- Chief Fletcher in attendance.
- 27 calls for the month.; 17 township, 6 in the village, 2 in Lodi and 2 in Seville. No MVA's in the month.
- Sealy manufacturing had two-hundred (200) mattresses ordered to help area hospitals handle their COVID-19 influx of patients. The hospitals did not need them and were not billed for them. 160 mattresses were donated to WFRD to distribute as they deemed appropriate. WFRD donated them to the Medina County health department. Sealy manufacturing has 38 additional mattresses to donate.
- Vital Oxide solution and the VAPORE machine were delivered last week. The applicator guns are still on backorder. An inservice training will occur soon.
- Training is resuming tonight at the WFRD, practicing social distancing. Forceful entry training.
- Three (3) EMS only members will participate in the volunteer FireFighter 36- hour course starting June 9th. They will receive certification in time to attend the firefighter one transition class hosted at the WFRD on July 14th.
- Mobile Area Radio Communication System (MARCS) radios are being programmed. The currently used 400 radio frequency will no longer be used starting in August. State funds were received last year to offset the cost of the radios. Our system will be able to communicate with the county's current radio system.
- All calls have been covered, none were missed in the last three months.
- No new updates on the larger sized 911-memorial pavilion.
