Chief Report-

- Chief Fletcher in attendance.
- 36 total runs for the WFRD. 14 fire, 21 EMS, 1 MVA. 26 township runs, 5 Westfield Village runs, 4 Lodi runs and 1 Seville run. 24 residents and 12 non-residents.
- Chief Fletcher finalized the date for the open house at the new fire station. It will be held on August 29th.
- Dept. of Public Safety EMS grant was received in the amount of \$3,638.27 and is good from July 1st through December 31st, 2020. This is a reimbursement grant program. The department will get reimbursed for the purchase of EMS equipment or COVID related purchases.
- The MARCS radios have been installed. All vehicles except one of them.
- Signage on the building is complete. The street sign appears to be misaligned. Fast Signs will send someone out to realign the sign at the road. Trustee Schmidt will reach out to Paul, at Fast Signs, to make sure it gets addressed.
- Two people have applied for the posted Lieutenant positions within the department. Both applicants have current or prior Lieutenant experience. Written and oral interviews will be held.

This check will be held until further clarification is received from Overhead Door Company of Akron. Trustee Schmidt believes the repairs should be covered under the warranty. The Trustees would like to wait on paying this invoice until further clarification is received.

- Trustee Horner asked for clarification on the out-of-pocket expense for the MARCS radios. FO Kurtz stated that WFRD had to pay approximately \$14.00 in addition to the grant monies to cover the cost of the radios. Additional programming for the radios was purchased as well. Fifteen (15) portable and six (6) mobile radios were purchased in all.
