Chief's Report

- -Chief Fletcher in attendance.
- July totals- 35 calls; 24 EMS, 9 Fire, 2 MVAs. 23 of the calls were in Westfield Township, 10 in Westfield Village, 1 in Lodi and 1 in Medina city for 35 residents and 5 non-residents.
- -OTARMA suggests that Lexipol be consulted to assist the WFRD with policy and procedure compliance and implementation (personnel and standard operating procedures). The company specializes in policy making and daily training bulletins (DTB) for employees. Lexipol is used by most police departments county-wide, including Westfield Village Police Department. Lexipol is offering a prorated discount for the remainder of the year \$342.00 total for September through December 2020. However, effective January 1st, 2021, the total annual fee would be \$2,843.00. OTARMA, in the past, has offered to pay \$1,000.00 toward the annual purchase price. The contract can be terminated at any time without penalty. If WFRD were to opt out of the contract, they can keep all their policies and procedures. Chief Fletcher will reach out to local fire departments to see if they are utilizing Lexipol and in what capacity. Chief Fletcher will check with OTARMA to ensure that they are willing to pay \$1,000.00 towards the cost. The trustees will review information regarding the program when the Chief forwards it.
- -Boy Scout landscaping project was completed Saturday, July 25th. The Fire Association donated \$1,500.00 towards the project. Chief is asking the Board of Trustees to consider donating money towards the Boy Scout project. Trustee Schmidt would like information regarding the amount of money the scouts raised towards their project before committing to monetary donations on behalf of the Township. Approximately 30-35 bushes were planted by the scouts at \$28 per bush. Tabled until next meeting.
