- -Chief Fletcher in attendance.
- -Chief's Report- 38 total runs for the month of October. 23 were EMS, 9 fire, 6 MVAs and 1 aero-medical transport. 31 runs were in the Township, 7 in the village for 25 residents and 13 non-residents.
- -Mask Up Medina Project- Community mask distribution organized by the Medina County Health Department. Free, disposable, non-medical masks were distributed during the hours of 10am-12pm on Friday, December 4th. Approximately 45 boxes (2,250 masks) were distributed by WFRD staff as cars drove through the fire bay doors.
- -Mr. & Mrs. Claus made an appearance via a firetruck at the Rory O'Neil Westfield ballpark parking lot on Saturday, December 5th from 10am-12pm. Kids were able to take pictures with Mr & Mrs. Claus (socially distanced) and the kids were given a book that was donated by local residents. Chief estimates that around 300 kids attended. Pictures were made available on the Fire Association's website.
- -5 Year Plan- Will focus on personnel development, training, response guidelines, fire prevention and vehicle maintenance and replacement. Chief expects the five-year plan to be complete by the end of January, 2021.
- -Lexipol Update- Chief is meeting virtually with Lexipol representatives later this week. The program should be up and running in a few weeks.
