Regular Meeting July 21, 2008 7:00 pm

Chairperson, Ms. Sims opened the meeting at 7:05 pm by asking those in attendance to stand and Pledge Allegiance to the Flag.

# **PUBLIC PARTICIPATION**

- R. J. Stallard resident at 5991 Eastlake Road, Lafayette Township had a complaint concerning the dust from the limestone coating that was put on Eastlake Road due to the extreme hot weather while a ditch enclosure was being installed. Mr. Stallard presented an estimate to have his RV washed (\$37.81) and an invoice of what the furniture coverings for his porch cost \$532.50. He asked for compensation in someway to help defray the cost of cleaning up the dust. The township swept and washed down the road Monday, July 21, 2008. The issue will be taken under advisement. There is a bump where the culvert crossed the road.
- ➤ Stanley Fox, resident at 5771 Greenwich Road wanted to know what was going on with the Zuber property at 5833 Greenwich Road (zoning violation) and the "junk yard" at the corner of Lake and Greenwich Road. Ms. Sims advised Mr. Fox that the Trina Devanney, Assistant Prosecutor is handling this case and it is in the hands of the prosecutor. Mr. Likley will give Trina Devanney a call tomorrow and ask what the status is on this case. Ms. Sims asked Gary to verify that all the vehicles are operable.
- ▶ Linda Botsch 6915 Buffham Road received a letter about a vehicle parked in my front yard. I felt that I have been singled out by the township. Gary had a complaint that concerning about the car and did not single this resident out. Ms. Botsch stated the car can be operable. Gary will give Ms. Botsch a copy of the junk car resolution and will verify that it is operable. It is Ms. Botsch's intention to get rid of the vehicle.
- ➤ Geo. Smerigan of Oxbow Consultants Presentation regarding a comprehensive plan. He is a professional planner and had done planning services for York, Litchfield, Montville Township, Zoning Resolutions for Brunswick Hills and York Township. Time Frame for a plan to be completed is an 8-10 month process. The board of trustees asked Mr. Smerigan to submit a written cost estimate.
