FIRE

Chief Fletcher reporting: (copy of report is attached)

- ➤ 16 runs for Nov.
- Students that submitted posters for the Ohio Firefighters Association contest were treated to a pizza party by the Fire Association. Students were given certificates and a large copy of their poster for their achievement. Winners: K-3rd grade, Paige Ferguson; 4-6th grade Samantha Good.
- December 10th breakfast with Santa
- Department is considering changing to a different billing agent (Medicount) has the ability to combine reporting and billing program. Initial cost will be a 2% increase for billing of the receipts for the first 4 years but a potential savings of 4% after that. Reason for increase is they are providing a computer and software. It will out-perform what we have now as we are still having issues with the present program. I am familiar with this company.
- Several departments in the county have signed up for code messaging. The cost is \$79 per month with a \$100 one-time set-up fee.
- Continue to meet with Westfield Companies Risk Management Committee
- Explorer troop completed a 2 ½ day CPR course and 9 were certified CPR administrators

OLD BUSINESS

RESOLUTION 2011-33 A RESOLUTION TO APPROVE EMERGENCY MANAGEMENT REVERESE 911

Trustee Harris made a motion to adopt Resolution 2011-33, seconded by Trustee Likley. Trustee Likley stated this will cost the township \$440.75 per year for this service which will be paid out of general fund.

Roll call: Harris, aye; Oiler, aye; Likley, aye.

Trustee Likley mentioned the chief's letter in September addressing a cost of living increase is not mentioned in his contract and also possible increase in vacation time plus the extension of his contract. We did approve the extension of his contract to 2016. Before our organizational meeting in January I wanted to address some of the other concerns the chief had. If compensation increase is in the works for the fire chief that we have some numbers prepared. We had talked in providing additional time off for the chief and I have prepared an amendment to our employee handbook as we do not address full-time salaried employees. A copy has been sent to Bryon Richter at the prosecutor's office for review as it addresses comp time hours that does not cost the township additional dollars. (copy in office for review)

Trustee Likley: At our last meeting a motion was made to rescind Resolution 2011-20 changing 6 properties on East Greenwich Rd. from RR to LC, do we have a resolution for that. Fiscal officer stated yes, it was prepared an certified as RESOLUTION 2011-34

Trustee Likley: Also at our last meeting we discussed the rescinding of the Comprehensive Plan that was passed September 26, 2011; I would offer that motion this evening.

Trustee Harris: I feel that the zoning commission made the correct recommendation, they put their time into it, they did their studies and I feel we should leave it as is.

Trustee Oiler: After re-studying, re-thinking and re-reading I have decided that I will stick with my vote, I will stick with my commitment and I believe the zoning commission did have the right professional people to discuss things with and bring out ideas and I believe the plan should stay as is and time to move on.

Motion dies for lack of second.

Trustee Likley: Mr. Scheetz's request for that to be amended will not be done.

NEW BUSINESS

Trustee Likley brought up the Gloria Glens fire-EMS contract expires Dec. 31, 2011. We need to address the contract. Lafayette will be meeting with Gloria Glens this week for fire & EMS services. Lafayette's millage is 3.5 mills. Westfield Township is at 1.5 mills. Trustee Oiler is extremely interested in working with Gloria Glens. Trustee Likley feels we need to add soft billing to the contract. The contract will be sent to legal counsel for the additional language. Trustee Likley will attend Gloria Glens council meeting Wednesday. Trustee Likley will do the delivering of the contract to Bill Thorne with the additional language.

Trustee Likley met with Mayor Horwedel to discuss the chief's salary. The mayor and fiscal officer desires to lessen the check writing. Fiscal officer, Martha Evans will look into a method that can reduce that aspect of the fire department's receipts & expenses. The mayor & fiscal officer suggested making the quarterly payments as established in our contract and crediting.
