Regular Meeting December 21, 2015

Trustee Schmidt called the meeting to order at 7:28 PM. Roll call: Likley- aye, Schmidt- aye, Thombsaye.

Comments from the floor- none

Minutes to be approved

Likley makes a motion to accept the meeting minutes from December 7, 2015 as corrected; seconded by Thombs. Roll call: Thombs- aye, Likley- aye, Schmidt- aye. The motion passes.

Road Report

- Slag for next year has been purchased and Evans will be getting the bids out early for the spring. The Township has enough for the roads that need to be done.
- Cloverleaf Schools have already received 10 tons of salt from Westfield Township for the school's use.
- Dodge needs tires (all six) approximately 51,000 miles are on them. North Gateway has some that will be purchased for \$1,215.54 (Synergy Tires) instead of Good Years that cost \$1,710.00.
- Evans will be taking off this week due to good weather and vacation days
- No word from the BMV for the 2 new employees.
- Stuckey Road is done- tree will be out in spring.
- West Buffham Road has been cleared of a fallen tree. Evans pushed into the woods.

Zoning Report

- Porter submitted Formal Request to Planning Services for formal review on proposed text (yard set- backs, driveways, fences).
- Proposed text language will be coming to Trustees by March for review.
- > Zuber Property- seems like there are more vehicles on this property. ZI Sims will talk with the new owners about zoning issues and get a new contact name.

- ✓ Recycle Bins- now have 2 bins on the premises.
- ✓ Solid Waste District next retreat meeting is January 8, 2016. Likley was reelected to the Solid Waste Board. The Board is still in the process of researching options for the facility.
