### **Fire Station Report**

- ✓ Thombs sent statement of 'Expenses for Station Construction' to the Trustees
- ✓ Thombs provided estimated cost of Community Building to the Trustees (estimated cost \$4,538,369.55 from DS Architect) and Reimbursements in the amount of \$158,372.40 for a grand total of \$4.696,741.95.
- ✓ Mary Beth will get estimated mileage to the Trustees first of the year after the resolution is passed and provide the Trustees the total amount (principal and interest for taxable evaluation)
- ✓ Thombs contacted Rebecca Princehorn and discussed how to submit a resolution asking for levy mileage information (4.5 million, 4.7 million and 5 million to build for 25 and 30 years at a 5% interest rate) and provide Princehorn the signed resolutions prior to January 1st. Trustees will provide multiple scenarios. Thombs will get packet to Princehorn with resolution
