Regular Meeting September 16, 2019

Trustee Schmidt called the meeting to order at 7:00 PM. with the Pledge of Allegiance. Roll call: Likley – aye, Horner – aye, Schmidt – aye.

Comments from the floor

- Terry Bower 9241 Friendsville Road
 - o After attending the August 5th Trustee's meeting, Mr. Bower called GPD reps regarding the cell tower proposed for his property
 - He has signed an option to explore the potential of an AT&T tower to be located in the SE corner of his property
 - o GPD will survey the property
 - o This Board is following ORC language and legal counsel from the Prosecutors Office.
 - 1 response of objection from Jeffery Howard was received, he is a neighboring property owner.

Roads Report

- R-cut construction at Westfield Road & Route 224 continues. Conduit was installed underneath
 the road for the possibility of lighting or lighted signs. Roads Supervisor Evans will follow up
 with the crew.
- School Bus Stop signs were installed on Daniels Road.
- The No Engine Brake sign at Hulbert & Mud Lake was stolen and will be replaced.
- An appointment will be scheduled to install plumbing for the brine tanks.
- Calls were made to Medina Fence & Austin Fence to install additional fencing & a guard rail around the fuel tanks which will protect pumps and hoses. A 3rd vendor will be called as well.
- All road striping has been completed.
- Evans met with the owner of 9800 Daniels Road about concerns of water running through the property. A pond is an option for the problem.
- Pursuing legal action against drivers insurance on damaged guard rail accident.
- The sight glass for the oil gauge on the Mack truck is leaking.

Cemetery

- 15 monuments were repaired. Vendor reps came out & adjusted couple of monuments.
 - The Grant request was denied due to incomplete paperwork as a W-9 form was not submitted.
